hreader> transfers the ownership of the above mentioned cat to Mr. /Mrs. <new owner> under the following conditions.

In this contract Mr. /Mrs. <br/> spreeder> will be called 'breeder', Mr. /Mrs. <new owner> will be called 'new owner'.

## 1. Acceptance by the new owner

When the new owner took over the cat, called *<name of cat>*, on *<date>*, it was free of visible parasites , dewormed, clean, in good general health condition and free of visible defects.

When this contract has been signed by both parties, the new owner has been informed about visible faults, as mentioned under article nr. 7, by the breeder, and the new owner accepted those faults without any further claiming of recourse and/or compensation.

The breeder is not liable for any illnesses of any kind or for any genetical defects, which might appear or occur, after the new owner has taken over the cat, the breeder does not take over any further compensation for those illnesses or genetical defects.

The new owner has been informed by the breeder about the restrictions concerning the breeding with this cat, as mentioned under article nr. 6, and the new owner has agreed with them. Changes concerning this breeding restriction are subject of the explicit permission of the breeder.

The new owner and the breeder sign a transfer paper, which will be forwarded by the new owner to the club/federation <name of the club> to confirm the transfer of ownership of the cat. This transfer paper will be forwarded to the new owner after confirmation by the concerned club/federation.

## 2. Transfer of documents

The following documents have been transferred by the breeder to Mr. /Mrs. <name> together with the transfer of ownership of the cat:

If the vaccination against Rabies is not complete (1<sup>st</sup> and 2<sup>nd</sup> booster), you may mention here that you have given a coupon for the 2<sup>nd</sup> booster to the new owner. Pls. note that for a transfer to a foreign country only a complete vaccination against vaccination will be accepted by the authorities.

## 4. Transfer of the cat by the new owner

The new owner is obliged by his signature on this contract that he is not permitted to transfer the cat to a pet shop, zoo or similar, he is also not permitted to transfer the cat to any laboratory, nor to any experimentation institute or similar, he is also not permitted to transfer the cat to any cat pensions of any type, otherwise the breeder is entitled to take legal actions against the new owner.

The new owner is also obliged by signing this contract that he makes an offer to the breeder, if he wants to further transfer the cat, to enable the breeder to take the cat back, i.e. when the new owner signs this contract the breeder gets the right of an advanced sale in any case.

## 5. Conditions to take the cat back

The breeder is obliged by signing this contract that he will take the cat back within 6 weeks after the transfer of the cat to the new owner, under the following conditions:

- The following price fort he cat will be re-reimbursed to the new owner ....
- The costs for a new test against FeIV, respective the costs for an inspection of the cat by a veterinarian are
  to be paid by the new owner.

## 6. Breeding

#### Alternative 1

The new owner is obliged to have the neutered cat in accordance to the remarks concerning breeding, which are issued on the cat's pedigree, further on the new owner is not entitled to use this cat for breeding.

#### Alternative 2

The new owner is obliged to use the cat transferred to him for breeding [in accordance with the remarks concerning breeding, issued on the cat's pedigree] only within a registered club/federation.

Those two paragraphs are to be seen as alternatives, which depend on the remarks issued on the cat's pedigree. I.e. if there is issued a prohibition for breeding on the cat's pedigree, alternative 1 is used. If there is issued another remark concerning breeding on the cat's pedigree, alternative 2 is used, the phrase written in brackets in alternative 2 may be omitted, if there is no remark concerning breeding issued on the cat's pedigree.

Here you may include further articles, such as:

#### Alternative 1

The new owner entitles the breeder that he may use the transferred cat for a mating with one of his cats, [after having paid a fee for the mating], and after having proofed by a vaccination passport or similar certificate, issued and signed by a veterinarian, this his cat which he wants to use for the mating has been vaccinated and/or tested against <vaccinations, tests>. This right for using the transferred cat for a mating with one of the breeder's cats is valid until <date>.

#### Alternative 2

The new owner entitles to breeder to get a kitten of his own choice from the next litter/from the next litters of the transferred cat, if the new owner used the cat for breeding, i.e. this is the right of an advanced sale.

Pls. Note, those 2 alternatives depend on the sex of the transferred cat, if the transferred cat is a male, alternative 1 may be used, if the transferred cat is a female alternative 2 can be used.

## 7. Important notes

The transferred cat has the following faults of which the new owner has been explicitly made aware by the breeder and which the new owner has accepted without any further recourse or compensation (such as f.e. costs for a veterinarian, costs for a lawyer, and similar costs):

Pls. list here all faults, which have visible and which have been noticed when the cat was handed over to the new owner.

Pls. note her also, if your cattery has been under quarantine, and note here also the reasons for the quarantine (f.e. the cattery has been under quarantine because of FIP).

Pls. inform the new owner also about eventual risks which he might take over when taking this cat (f.e. there might be the possibility that the cat might get FIP).

# 8. Other notes

A guideline for feeding and keeping the cat is appended to this contract by the breeder.

The new owner may ask the breeder about feeding and keeping the cat.

Rosettes, cups, other prizes which the cat had been awarded on shows have been handed over by the breeder to the new owner together with judges reports/certificates.
